

THE PAMPERS CRATE & BARREL SWEEPSTAKES
OFFICIAL RULES. NO PURCHASE/POINTS NECESSARY TO ENTER THE SWEEPSTAKES.
A PURCHASE/POINTS DOES NOT INCREASE YOUR CHANCES OF WINNING.

- 1) **Sweepstakes Timing:** The Pampers Crate & Barrel Sweepstakes (the “**Sweepstakes**”) begins 12:00 a.m. Eastern Time (“**ET**”) on 3/1/2019 and ends at 11:59 p.m. ET on 5/31/2019 (the “**Sweepstakes Period**”).
- 2) **Eligibility:** The Sweepstakes is open only to legal residents of the 50 states of the United States and the District of Columbia who are 18 years of age or older as of the last day of the month prior to date of entry and Canada (excluding Quebec) who are 19 years old or older as of the last day of the month prior to the date of entry. Employees of The Procter & Gamble Distributing LLC (the “**Sponsor**”), Don Jagoda Associates (“**Administrator**”), Crate & Barrel, their respective parents, subsidiaries, divisions, affiliates, suppliers, distributors and advertising, promotional and judging agencies, and their immediate family members (spouses, parents, children, and siblings and their spouses) and household members of each (whether related or not), are not eligible to participate or win. To join the Pampers Rewards program and for the complete list of Pampers products that contain Pampers Rewards codes and the corresponding Pampers Rewards Points, U.S. residents may visit www.pampers.com and Canadian residents may visit www.pampers.ca (the “**Websites**”).
